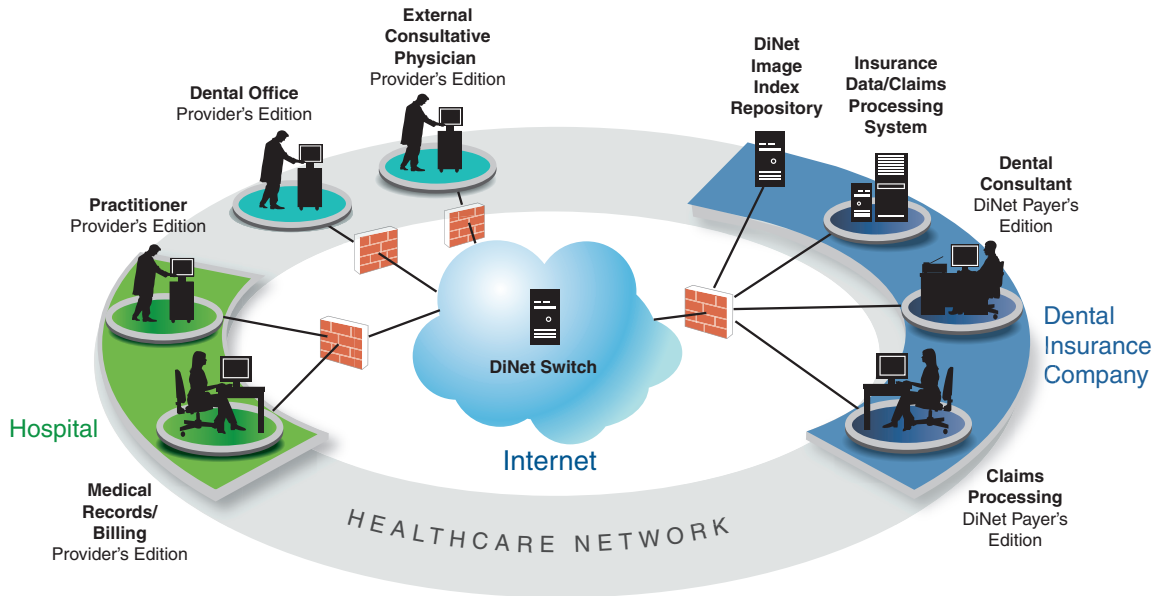
Compatible with your existing systems — Send high-definition images from any Microsoft Windows program including your existing practice management and dental imaging systems.
